- a. Account balances
  - Core Ops: account balances nearly \$700 lower
- b. Monthly Surplus/Deficit
  - Core Ops: \$1K deficit for month
    - Revenue almost \$2K lower; Expenses \$1K lower
- c. Exceptional items
  - Pond Fishing Tournament
    - Net benefit: (\$96), including expenses paid in Dec
      - (not all #s are reflected in the November Treasurer's report)
- d. Expense Items of Note
  - Repair & Maintenance
    - Fire Protection Services
      - Inspection & some repairs: \$665
    - Landscaping / Groundskeeping
      - Weed trimmer & chain saw purchased: \$513
  - Other Misc Expenses
    - 'only' \$1.76 in bank fees
    - (reflects migration of online charge processing to Omella)
  - Telephone: \$94.32
    - 'temporary' charges related to migration of main phone service to Google Voice
- e. Income Items of Note
  - Pond
    - Donations & food sales: \$305.50
  - Memberships
    - 1 membership (Associate)
    - \$40 (+\$40 donation)
  - Apartment
    - \$2K: Security deposit + 1 month rental
  - Facility Usage
    - Ranch Room: (\$305) client changed rental to Community Hall, reversing October's \$305 in income.
